This year's results were outstanding. Over the past four months, we have distributed thousands of nomination forms throughout the tricounty area. The result was an overwhelming 1200 nominations from attorneys throughout South Florida.

To keep the nomination process fair and to keep larger law firms from dominating the arena by nominating their own, we set up a

point system. Each out-of-firm nomination was worth one point in-firm while an nomination was worth one-half point. Nominations were only accepted from Florida licensed attorneys. This year, we also accepted nominations in the areas of pro bono and public practice.
